Application	Instituto Cervantes	<p>Amount due by the candidate centre in order to process the application and start the accreditation process, including a verification of minimum requisites.</p> <p>This service is always processed at Instituto Cervantes headquarters and implies the elaboration of an initial technical and academic report.</p> <p>The payment needs to be done exclusively when submitting the accreditation application.</p>	€ 425
Annual Accreditation	Instituto Cervantes	<p>Accreditation service to access the different benefits associated to the accreditation: recognition and use of the logo and the denomination of "Centro Acreditado por el Instituto Cervantes", international promotion as accredited centre by the Instituto Cervantes, development and reflection of the centre's activity, orientation towards a continuous improvement.</p> <p>Amount due annually by the accredited centres during the extension of their accreditation contract.</p>	€ 1.850
New facilities verification	Instituto Cervantes	<p>Required service in case of change of the address/facilities that appear in the accreditation contract where a centre may have moved after being evaluated. This service includes a visit to centre to verify the new facilities and check its conditions as well as legal and security details.</p> <p>The centre also needs to cover all the travel expenses of the designated assessor related to the visit (transport, hotel and per diem) that are not included in this fee.</p>	€ 600

Type of service	Evaluation Agency	Fees description	2019 Fees
Centre Pre-evaluation	Any of the Evaluation Agencies recognized by the SACIC	Amount due just by the centres that would like to better prepare the evaluation previous to the accreditation. This service includes a visit to the facilities, a meeting with the staff, an analysis of the documentation that the centre needs to prepare and the elaboration of a recommendation report about their accreditation process. This service is optional . Any candidate centre can ask directly to be evaluated by an evaluation agency without completing the pre-evaluation service.	€ 1.300
Technical-academic Dictum	Any of the Evaluation Agencies recognized by the SACIC	Amount due by the centre for an evaluation service, including an evaluation visit to the centre, the issue of the technical-academic dictum and the elaboration of an evaluation report by the selected evaluation agency. This type of evaluation, also call evaluation model 1 of the SACIC , is required to have access to the accreditation as well as to process the second extension of the accreditation on the sixth year of contract. The centre also needs to cover all the travel expenses of the designated assessor related to the visit (transport, hotel and per diem) that are not included in this fee.	€ 1.800
Ratification Report	Either the Evaluation Agency selected for the previous evaluation or the Instituto Cervantes	Amount due by the centre for the evaluation service necessary to process the extension of the accreditation. This includes a ratification report done by either the Evaluation Agency selected for the previous evaluation or the Instituto Cervantes. There is no need of an evaluation visit as in the previous cases. This type of evaluation, also call evaluation model 2 of the SACIC , is required to process the first and third extension of the accreditation contract.	€ 1.250
Dictum revision/ non favourable report	Either the Evaluation Agency selected for the previous evaluation or the Instituto Cervantes	Amount due by the centre, either during the initial evaluation or during the following ratifications, in cases where the obtained dictum is non favourable. It can be requested only when fulfilling a certain requirements. The centre also needs to cover all the travel expenses of the designated assessor related to the visit (transport, hotel and per diem) that are not included in this fee.	€ 650
